ELITE PITCHING AND CATCHING: 9 - 11:30 AM

Cost: \$90 | Check-In 8:30 - 9 AM

Pitching session will include fundamental breakdown and pitch development. Focusing on spins, body position, and ability to create speed and power. Catching session will have an emphasis on receiving, blocking, and throwing to all bases. Pitchers and catchers will work together throughout this session. (Pitchers don't need catchers.)

Defense will be broken up by positions and will cover proper footwork, angles, range, overhand throwing techniques, and many other fast paced skills that will mimic a U of I Softball Team Practice. Hitting sessions will offer drills and philosophies that are embedded in the Illini program.
